I offer my full support for Winston (Win) Chamberlain, MD, PhD for the role of EBAA Chair of the Board of Directors. Win became involved with VisionGift in 2009, the year after he joined the faculty at the Casey Eye Institute. His intelligence, enthusiasm, character, and outspoken nature were all apparent from the start.

Since Win's career began in Portland, he's transplanted over 1,100 corneas. This remarkable testament to the impact he has had on the lives of his patients is foundational to the "why" behind Win's commitment to our field. Win has always understood that these 1,100 transplants could never happen without eye banks. And his commitment to the stewardship of these precious gifts and a robust eye banking profession has blossomed over the past 15 years. Additionally, he promotes the importance of evidence-based stewardship of the altruistic gift of sight.

Win has dedicated enormous amounts of his time to our profession. From accreditation site visits to running MAB meetings. From signing off our trainers every year to tissue consultations. He is well known by our staff and eye bankers across the Association because of the amount of work he does for the Association. And for nearly three years, he has served on the EBAA Board. He is well versed in the current issues the field faces (e.g. changing technology, reimbursement, consolidation, competition).

Win is willing to dedicate six additional years of his professional life to EBAA service. While every Chair's challenges will be unique, Win is aware of the time commitment ahead. We spoke of his desire to ensure a successful Association long into the future.

It's my opinion that our tradition of physician leadership is a powerful way to ensure visibility and relevance with our surgeon partners.
