Exhibitor Guidelines

Exhibitor Move-In

Exhibitor move-in will take place Wednesday, June 25, 12 pm - 4 pm. In order for your boxes to be delivered to the exhibit hall, this form MUST be completed and sent to the hotel; details about the shipping address can be found on the second page of the form.

Exhibitor Move-Out

Exhibitor move-out will take place on Saturday, June 28, 10:30 am - 1 pm, following the morning break in the Exhibit Hall.

For out-bound shipping, this form with your billing information and how many boxes are going out must be completed. The Loews Conference Services contact will walk around the exhibitor hall to collect the signed forms and identify the boxes that are going out. Boxes should be sealed and properly labelled with your preferred shipping company (UPS, Fedex, etc). Loews housemen will bring the packages down to our loading dock for Fedex and UPS to pick up.
